Please note: **Agreements must be returned to our office 14 days from the date sent to guarantee your date.** If this is a problem, please notify our office.

PREPARATION: Dansations will require the performance area ready at least 60 minutes prior to the scheduled performance for set up and 60 minutes after the performance for take down. Dansations requires *at least* one circuit near the performance area that adheres to contemporary safety standards and supplies to us at least 15 amps. Additional circuits needed for school events, multiple sound systems or packages with lighting added. Preparation of the performance area is the responsibility of the Customer even if the Customer isn't the owner/operator of the performance area. Failure of the performance area to be ready may necessitate a delay/cancellation of the performance and Dansations shall not be obligated to extend the performance times nor reduce the amount of Full Payment.

DAMAGES: Customer shall be responsible for the safety and security of Dansations equipment from the time of Dansations arrival at the performance area to the time of Dansations departure after take down. Client is responsible to any damage caused to Dansations equipment by any guests or attendee. Dansations reserves the right to end the scheduled performance due to failure of the Customer to provide adequate safety and security. Customer is fully liable for events that may ensue from the failure thereof. Dansations shall not be liable in excess of the booking fee.

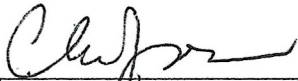
CANCELTIONS / BREACH: In the event of cancellation / postponement of said event, Dansations must be notified **within 60 days of event**. **Cancellation outside of 60 days is a forfeit of the booking fee paid. If cancelled inside of 60 days, the client is still liable for the booking fee and balance due.** In the case of ill health or equipment malfunction, Customer will be responsible for only that portion of Full Payment corresponding to the amount of performance delivered. Dansations shall in no event be held responsible for preparatory expenses incurred by Customer, and Customer shall not be responsible for preparatory expenses incurred by Dansations.

ENTIRE AGREEMENT: This agreement supersedes all agreements previously made between us and relating to it's subject matter. There are no other understandings or agreements.
